SP MP Sanjay Seth resigned from RS, likely to join BJP

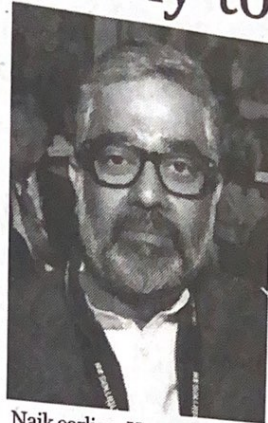

Samajwadi Party MP Sanjay Seth on Monday resigned from the Rajya Sabha and the party. He is likely to join the Bharatiya Janata Party (BJP).

Seth is the third MP to have resigned from the party as well as the Rajya Sabha after Neeraj Shekhar and Surendra Nagar who had submitted their resignations and joined the BJP.

As sources here maintained Seth's resignation is a big blow to the party as he was not only party's national treasurer but also considered to be close to the Yadav family.

As Seth is close to the Yadav family, so party chief Akhilesh Yadav also recommended his candidature for MLC to the governor Ram



Naik earlier. However, being not eligible for the MLC post, the governor turned down this request of the SP. Then he was sent to Rajya Sabha.

Seth is among the top builders in central Uttar Pradesh. With the exit of Seth, the SP is now left with just ten members in the Rajya Sabha.

With exit of many leaders

of late from the party, the SP now seems to be battling hard for its own survival. First it was family feud followed by crushing defeat in the Lok Sabha elections and now quitting of many party leaders seems to have badly affected the morale of the SP cadre.

Neeraj Shekhar, son of former Prime Minister Chandra Shekhar, hails from Ballia. So he to have strong hold in the eastern belt of UP. That may again cause trouble for SP politically in that region.

Seth seems to have strong hold in Central UP and is one of prominent builders of UP, while Nagar who resigned from Rajya Sabha on August 2, is a Gujjar leader from Western UP. That is why their exit is a big loss for the SP.
